- ✓ **Individual grants for researchers for Research and Training projects**
- ✓ **Mobility**
- ✓ **Duration: minimum 12 / maximum 36 months**
- ✓ **Grants cover all expenses**
- ✓ **Bottom-up approach in all discipline**

EUROPE

EU Member States (MS) and their overseas departments (including Overseas Countries and Territories (OCT) linked to MS)

and Associated Countries (AC), i.e. non EU countries who signed agreed an agreement with the EU to be part of Horizon 2020 Programme

THIRD COUNTRY

Non-associated Third Countries (TC) are countries which are neither EU Member States (MS), nor associated to Horizon 2020 (AC)¹.



EXPERIENCED RESEARCHER

researcher **with a PhD title**

or

at least 4 years of research experience
(full-time equivalent)



at the call deadline (11/9/2019)

No restriction about the age!

Open to all nationalities (with some restrictions)!



PARTECIPATING ORGANISATIONS

BENEFICIARY

The host institution in **EUROPE** in charge of:

- **Recruiting, hosting, supervising and training** the funded researcher
- **Signing the Grant Agreement**, receiving funding, claiming costs and taking complete responsibility for the proper implementation of the action

Only **ONE** beneficiary per proposal

PARTNER ORGANISATIONS

They do **NOT** sign the Grant Agreement and they do NOT claim any cost.

- Institutions in **EUROPE** providing additional training and hosting the researcher during secondments.
- Only for Global Fellowships: organisations in **THIRD COUNTRIES** that host the researcher during the compulsory initial outgoing period and provide additional training.



ACADEMIC SECTOR

- Public or private higher education establishments awarding academic degrees
- Public or private non-profit research institutes whose primary mission is to pursue research
- International European Interest Organisations (IEIO)

NON - ACADEMIC SECTOR

Any entity that is not Academic. E.g.:

- Business organizations
- SMEs
- government, local or regional authorities
- civil society organizations (NGOs, trusts, foundations, etc.),
- cultural institutions
- museums
- hospitals
- international organizations (like WHO)

 **INTERSECTORAL COLLABORATION** 

The sector depends on how the organization is registered on the EC portal



SUPERVISOR

The **scientist** appointed at the host institutions that **supervises the researcher** throughout the whole duration of the action

For European fellowships:

- one supervisor at the beneficiary (in Europe)

For Global fellowships:

- one supervisor at the beneficiary (in Europe)
- one supervisor at the partner organization (in Third countries)

For Secondments:

A mentor in each host institution





LONG -TERM RESIDENCY

A period of legal and continuous residence
within Europe (MS or AC)
of **at least 5 consecutive years** in the past

with a maximum of total 10 months of absence
and for periods shorter than 6 months each
within this 5 years time span

MOBILITY RULE

All Marie Curie Fellowships require that the researcher moves from one country to another one!

Standard Rule: The researcher must **NOT** have resided or carried out the main activity (work, studies, etc.) for more than **12 months in the 3 years** immediately before the call deadline (12/09/2016 – 11/09/2019)

- **European Fellowship:** in the country of the beneficiary
- **Global Fellowship:** in the third country of the partner organization

Specific rule for some panels EF-CAR, EF-RI, EF-SE: The researcher must NOT have resided or carried out the main activity (work, studies, etc.) in the country of the beneficiary for more than **36 months in the 5 years** immediately before the call deadline (12/09/2014 – 11/09/2019).

The rule refers both to the actual place where you live and the place of your work. Short stays, participation to conference, holidays are not considered

GLOBAL FELLOWSHIPS - GF



Standard European Fellowship (EF-ST)

To EUROPE
12-24 months



Financial support to individual researchers from any country who chose to an host institution in Europe.
It is the basic, standard type.

- NATIONALITY: Any nationality
- MOBILITY: not lived/worked in the MS/AC for more than **12 months in the last 3 years** (12/09/2016 – 11/09/2019)
- DURATION: The fellowship 12 – 24 months



Career Restart Panel (EF-CAR)

To EUROPE
12-36 months



Financial support to individual researchers who wish **to resume research in Europe after a career break** (e.g. after parental leave, working outside research, etc.)

- **CARRER BREAK:** Not active in research for at least **12 months within the 18 months** prior the deadline of the call (12/03/2018 - 11/09/2019)
- **NATIONALITY:** Any nationality
- **MOBILITY:** not lived/worked in the MS/AC for more than **36 months in the last 5 years** (12/09/2014 – 11/09/2019)
- **DURATION:** The fellowship 12 – **36** months



Reintegration Panel (EF-RI)

To EUROPE
12-24 months



Financial support to researchers who wish to return and reintegrate in a long term research position in Europe

- NATIONALITY: MS/AC national or MS/AC long-term resident
- MOBILITY: has not lived/worked in the MS/AC for more than 36 months in the last 5 years (12/09/2014 – 11/09/2019)
- DIRECT MOBILITY: Must move directly from TC to the chosen MS/AC
- DURATION: The fellowship 12 – 24 months



Society and Enterprise Panel (EF-SE)

To EUROPE
12-24 months



Financial support to researchers seeking to work on research and innovation projects in the non-academic sector.

- BENEFICIARY must be an **entity from non-academic sector**
- NATIONALITY: Any nationality
- MOBILITY: not lived/worked in the MS/AC for more than **36 months in the last 5 years** (12/09/2014 – 11/09/2019)
- DURATION: The fellowship 12 – 24 months



GLOBAL FELLOWSHIPS - GF



Financial support to individual researchers who spend a period outside Europe and then return to Europe.

- **NATIONALITY:** MS/AC national or MS/AC long-term resident
- **MOBILITY:** has not lived/worked in the TC for more than 12 months in the last 3 years (12/09/2016 – 11/09/2019)
- **DURATION:** The fellowship 24 – 36 months, thereof
 - Outgoing phase: 12-24 months in the TC (*Partner organization*)
 - Return phase: 12 months in MS/AC (*Beneficiary*)

WIDENING FELLOWSHIPS

Not a Marie Curie fellowship,
but an opportunity!

- Only for **European Fellowship** applicants
- who have chosen a European country with low performance in research and innovation (= **Widening Country**)

Associated Countries: Albania, Armenia, Bosnia and Herzegovina, Faroe Islands, North Macedonia, Georgia, Moldova, Montenegro, Serbia, Tunisia, Turkey and Ukraine.

RANKING LIST

EF-ST and GF

One ranking list for each scientific areas

EF- CAR, EF-RI, EF-SE

One multidisciplinary ranking list (including all 8 scientific areas)



SECONDMENTS

Temporary transfer of the Experienced Researcher in another host institution in Europe (Partner Organization) to perform part of the research and training project

- Presence of a particular **expertise necessary** for the implementation of the project in the Partner Organization
- Secondments are **optional**, but (If present) they must be **relevant** for implementation of the project
- Secondments provide **essential skills and knowledge** related to the project
- Specific supervision arrangement (e.g. mentor in the partner organization)



- It can take place at one or more organizations (**academic or non-academic**)
- In the same country as the beneficiary or in another European country (in any case: **only in Europe!**)
- Planned in a single period or divided into shorter mobility periods.
- **DURATION:**
 - Max **3 months** of secondments for a fellowship \leq **18 months**
 - Max **6 months** of secondments for a fellowship $>$ **18 months**
- **FOR GLOBAL FELLOWSHIP:** an optional secondment at the start of the project for a maximum of 3 months. This initial secondment will be considered as part of the outgoing phase.



SECONDMENTS are NOT SHORT VISIT

SECONDMENTS


- the goal is to gain knowledge and experience
- only in Europe
- with specific supervision arrangement

SHORT VISITS

- the goal is to gather data and information (e.g. field work)
- anywhere (Europe and beyond)
- under the supervision of the Supervisor of the Beneficiary

Brexit

What happens to my
Marie Curie if UK leaves
the EU?

Brexit might be hard or soft!

Brexit with agreement:

UK keeps on being eligible for funding and is considered as if it still were a EU Member State

Brexit without agreement, aka Hard Brexit:

UK becomes a third country and it is no longer eligible for funding. It has to renounce to the EU funding also for the ongoing projects!
