CALL FOR THE AWARDING OF A RESEARCH FELLOWSHIP

THE RECTOR

Given Law no. 240 of 30/12/2010, and in particular Art. 22 and Art. 18(1b) in the version in force before the Law no. 79 of 29/06/2022;

Given the "Regulations for the Awarding of Research Fellowship Collaborations", issued by Rectoral Decree no. 2979 of 31/03/2023;

Given art. 4.3 of the Regulations above, providing that the University may reserve a quota of research grants for Italian or foreign scholars who hold a PhD or equivalent title or to international scholars who have been awarded the PhD title in Italy.

Given Legislative Decree no. 196 of 30/06/2003;

Considering that the University of Verona has been a member of the "Scholars at Risk" international academic protection network since 2018 and of the Italian section "SAR-Italy" founded in 2019;

Considering the growing number of scholars at risk seeking placement at European universities;

Given the resolutions of the Academic Senate and the Board of Directors of 28/05/2024;

Given the expressions of interest and the research topics reported by the University Departments; and **having evaluated** every appropriate element;

DECREES

ART. 1 - SELECTION FOR AWARDING 1 (ONE) RESEARCH FELLOWSHIP TO BE ASSIGNED TO A SCHOLAR AT RISK

This document announces AdR4630/24 selection process based on qualification, research project and interview to award no. 1 (one) research fellowship at the University of Verona. The fellowship is for 12 months, with the possibility of renewal in accordance with law and subject to the availability of funds.

The selection is open to scholars who conduct research activities on the scientific topics listed below. Candidates can apply only for one topic and submit a research project in line with it.

ART. 2 - REQUIREMENTS

For admission to the selection process referred to in Art. 1, potential candidates must fulfil the following requirements:

- a) A PhD title relevant to the selected research project, awarded by an Italian or foreign university, or equivalent qualification obtained in a Foreign Country;
- b) A professional and scientific CV suitable for the research activity described in the art. 1;
- c) Adequate knowledge of Italian and/or English and/or other working language specified for the selected research topic;
- d) Being a non-Italian citizen in one or more of the following positions:
 - (1) recognized as an "at-risk scholar" by SAR (SAR-status) or by other accredited international organizations who work in this field [i.e. Scholar Rescue Fund (SRF) and Council for At-Risk Academics (CARA)].
 - (2) possession of international protection status in Italy or in another EU Country;
 - (3) possession of refugee status in a State that signed the Geneva Convention;
 - (4) possession of special protection in Italy or asylum seeker in Italy.

Candidates should attach to the application the available documentation related to their the 'at-risk' status recognized by SAR or other accredited international organizations who work in this field, or to their refugee / international protection status or asylum request.

Those with any relationship to, or ties with, a professor of the Host Department, the Rector, the Director-General or any member of the university Board of Directors, up to the fourth degree inclusive, may not participate.

The research fellowship may not be awarded to any permanent staff of universities, public institutions or public entities for research and experimentation, the National Agency for New Technologies, Energy and Sustainable Economic Development (ENEA) or the Italian Space Agency (ASI), nor to permanent staff at any institution whose advanced academic degree has been recognised as equivalent to a PhD pursuant to Art. 74(4), Presidential Decree no. 382 of 11/07/80.

In order to be admitted to the selection process, potential candidates must meet the stated requirements at the time of the application deadline. Failure to meet these requirements may result in the applicant being excluded from the selection process with due decree by the Rector.

ART. 3 - APPLICATIONS AND RULES FOR SUBMISSION

Applications, written on plain paper following the outline attached to this call for applications (appendix: Form A) and addressed to the Rector of the University of Verona, may be submitted sending the Form A and related attachments in pdf format, to the e-mail address <u>ufficio.protocollo@pec.univr.it</u>, within the peremptory deadline of 30 August 2024, 1.00 PM Italian time indicating "Application to the AdR4630/24 Call for the awarding of a research fellowship" as the e-mail object.

The submission may also be made by an unaudited electronic mail address. No other forms of application submission are admitted.

Upon receipt of the application, an anonymous identification code will be sent to each candidate and it will be used for the publication of all selection-related documents.

Pursuant to Art. 76, Presidential Decree 445/2000 and aware of the criminal penalties for false statements, candidates must state in their application:

- 1) personal details, date and place of birth, nationality, residence address, e-mail address, Italian tax identification code (if any) and contact address for the selection procedure (including the postal code and, if possible, a phone number)
- 2) to fulfil all the requirements indicated in Art. 2 of this Call, and not to fall into any of the incompatibility categories outlined in this Call;
- 3) that they have no prior criminal convictions, or otherwise report any criminal convictions (even if they have been granted amnesty, cancellation, pardon or legal pardon) or criminal proceedings against them;
- 4) that they have the required qualification as given in Art. 2 of this call for applications, and state the qualification and the date and place where it was awarded. Foreign nationals must also specify if their qualification, if it was awarded abroad, has received official recognition for equivalency to an Italian qualification;

For the evaluation of qualifications and experience, candidates must attach to their application:

- 1) a declaration in lieu of an affidavit regarding their qualifications gained, stating the award date, the issuing university and any grade reported.
- 2) their academic and professional CV, publications and relevant qualifications as per Art. 6 of this call for applications;
- 3) a research proposal (appendix Form C);
- 4) motivation letter;

- 5) available documentation related to their the 'at-risk' status recognized by SAR or other accredited international organizations who work in this field, or to their refugee / international protection status or asylum request. After the closing of the call, the Selection Committee will ask for confirmation to SAR, Scholar Rescue Fund (SRF) or Council for At-Risk Academics (CARA) about the documentation submitted by the selected candidates.
- 6) a copy of an ID card, or other form of identification.

The aforementioned documents must be submitted by the application deadline as plain paper photocopies accompanied by a statement that they are identical to the original. Alternatively, the candidate may produce a substitutive declaration reporting the important information contained in these documents. For this, candidates may use Appendix Form B. The signature at the bottom of the application is not subject to authentication, in accordance with Presidential Decree no. 445/2000.

Administration does not assume any responsibility if the applicant is unable to be contacted or for the loss of documents due to errors in the address provided by the applicant or for a failure to/delay in notifying a change of the address stated in the application, nor for any postal delivery errors or otherwise which are attributable to third parties, unforeseeable circumstances or force majeure.

In any case, any applications which are not signed or that, for any reason, including force majeure, are received by the University of Verona after the above-mentioned deadline, will not be considered.

Administration reserves the right to perform checks to verify the truthfulness of substitutive declarations. If such investigations reveal that any declarations are false, the applicant will be excluded from any benefits they may have been awarded from provisions made on the basis of the false declaration, notwithstanding the provisions of Art. 76, Presidential Decree no. 445/2000.

Pursuant to Law no. 104 of 05/02/92, candidates with a disability must make a specific request in their application regarding any aid required to perform the online interview.

ART. 4 - EXCLUSION FROM THE SELECTION PROCESS

Candidates are admitted to the selection process under the condition that the Rector may, with due reason, exclude those who do not fulfil the selection requirements from the selection process at any time.

ART. 5 - SELECTION COMMITTEE

The Selection Committee shall be constituted after the expiry of the call and its composition will be made known promptly by means of a Rector's Decree and will be made available on the website http://www.univr.it/it/albo-ufficiale. It will be organized into subcommittees, one for each Department, made up of three members (lecturers or experts in the disciplinary sector related to the subject, or similar) as established by Art. 20 (1a) of the Regulations referred to in the introduction.

ART. 6 - SELECTION PROCEDURE

The selection procedure takes into consideration an evaluation of each candidate's qualifications and experience, a motivation letter as well as an interview.

For the evaluation, the Selection Committee can award up to 100 points to each candidate: up to 80 points for qualifications and research project and up to 20 points for the motivation letter and final interview.

For safety reasons, considering the at-risk situation of applying candidates, the University of Verona guarantees the respect of the candidate's anonymity throughout the duration of the selection process. The results will be published using the codes associated with the applications and will not disclose the candidate's nationality.

The selection will be organized in two steps:

First step: Evaluation made by the Departmental subcommittees.

The evaluation of qualifications and of the research project will be based on the documents submitted by the candidates and following an interview to discuss the research project.

For the evaluation of qualifications up to 50 points may be assigned, as below described:

For the evaluation of the **research project**, including the related interview, **up to 30 points** may be assigned.

Second step: Evaluation made by the Selection Committee.

Candidates will be considered suitable to access the second step of the evaluation procedure (final interview and evaluation of the motivation letter) if they gain at least 55 points out of 80 after the first step of the evaluation. The interviews will be conducted in Italian or English language.

The list of applicants admitted to the final interview, which contains the codes assigned by the system at the time of submitting the application, and details on the date and time of the interview will be announced by e-mail to each candidate and published with a (minimum) three-day notice on the website of the University: Official Register and Cooperation activities section,

The second step of the selection process will be considered passed with at least 12 points out of 20.

To take part in the interview, candidates must provide a current, valid ID document. Candidates who do not show an ID document or have only an expired ID document will not be admitted to the interview.

Candidates must ensure that the workstation from which they will hold the interview is equipped with a webcam, necessary for recognition, and equipped with a microphone and headphones or audio speakers.

Failure / incorrect communication of personal contact details, failure to connect and / or unavailability of the candidate on the day and time established, or failure to show the identification document will be considered a waiver of participation in the interview, and therefore of selection, whatever the cause.

The final score will be made by the sum of the different scores (criteria no. 1 + 2 + 3). The results of the selection process will be communicated to the candidates by the Selection Committee after the interview.

ART. 7 - RANKING LIST

The steps of the selection procedure, including the ranking list, shall be approved by Rector's Decree. The ranking list will be concurrently published in the Official University Register on the web page: https://www.univr.it/en/official-register. The selected candidate and the hosting department will be

notified by e-mail with all necessary details on the further steps to be taken to accept the grant and stipulate the contract.

ART. 8 - CONTRACT

Research fellowships are awarded through the stipulation of a personal contract for research collaboration. Such contracts do not imply any form of employment and do not give the holder any priority for accessing permanent university positions.

Recipients who do not present themselves by the specified date, do not sign the contract or do not start the research at the determined time shall lose their right to the fellowship, except in cases provided for by the university's "Regulations for the Awarding of Research Fellowship Collaborations" referred to in the introduction.

The fellowship recipient's responsibilities are those established in the aforementioned University Regulations. In particular, the fellowship recipient shall collaborate on research regarding the project for which this call for applications was announced.

The total amount of the fellowship, net of administrative burden, is € 28,000.00 (approximately 1,650.00 Euro net per month) to be paid to the recipient in deferred monthly instalments. If the research fellow is a beneficiary of a co-financing provided by international organizations (e.g. Scholar Rescue Fund), this amount will be added to the fellowship amount already guaranteed by the university.

Research fellowships are subject to taxation under the provisions of Art. 4, Law 476/84 and subsequent amendments and additions, as well as social security, under the provisions of Art. 2(26) and following of Law 335/95 and subsequent amendments and additions.

The University provides the necessary support for requesting a visa and, once in Verona, for applying for a residence permit. The research activity can only start when the fellow is in possession of a regular residence permit enabling to carry out the activity or the documentation related to the regular request of the residence permit already submitted to the Police Headquarters.

The University provides insurance cover of accidents related to conducting the research. The expenses are to be paid by the fellowship recipient and the premium is deducted from the fellowship amount. The University also provides cover for third party liability, the expenses being covered by the university. Registration fees to the National Healthcare System (SSN) or to private healthcare insurance coverages for non-EU fellows will be refunded.

The University offers free accommodation in a guest house for the research fellow. In the presence of accompanying persons, the necessary support will be provided for searching for a suitable housing solution and for the regularization of accompanying family members entering to Italy.

The fellowship cannot be accumulated with other fellowships of any kind, except those granted by national or foreign institutions that are intended to contribute towards conducting a part of the recipient's research assignment abroad.

At the time of signing and for the total duration of the contract, fellowship recipients may not be employed, nor may they establish an employment contract, even temporary, with any private entity or public administration. Should they be already employed, a fellowship contract will not be stipulated unless the employer puts the recipient on leave without pay by a date given by the University.

Provided they perform their assigned tasks, fellowship recipients may carry out professional activities or other independent work if this is authorised beforehand by the Board of the Department, having consulted with the academic supervisor, and provided that the activity:

- is compatible with conducting research activities;
- does not represent a conflict of interest with the specific research being conducted by the fellowship recipient;
- does not lead to prejudice to the University in relation to the activities being carried out.

Fellowship recipients may not attend Bachelor's, Master's or PhD programmes with a fellowship, nor medical specialisation programmes, in Italy or abroad.

ART. 9 - SAFEGUARD PROVISIONS

For matters not provided for by this announcement, please refer to the relevant applicable provisions insofar as compatible.

The University of Verona is the owner of the processing of the personal data of the participants in the selections, pursuant to EU Regulation 2016/679; detailed information on the purposes of the processing, recipients of the data and exercise of the data subject's rights is available on the University's institutional website: https://www.univr.it/it/privacy.

This call for applications shall be publically published in the electronical Official University Register on the web page: https://www.univr.it/it/albo-ufficiale.

In the event of any discrepancies between the Italian and the English version of the Call, the Italian version shall prevail.
